# NCRE Regional Updates

## Region I:

**Springfield College** is in the third year of an RSA Long-Term Training Grant. The College is holding its Induction Ceremony for new Chi Sigma Iota members on 10/22 at 1:30pm. The Rho Alpha Xi Chapter had previously been dormant for several years.

On April 30<sup>th</sup>, 2010, Faculty and students from Region 1 met to discuss the major events and topics of the 2009 NCRE Spring Conference in Manhattan Beach, CA, current happenings and concerns in each of our programs, and continued opportunities for collaboration.

Tom McCarthy from Assumption and Mike Accordino from Springfield College are collaborating to generate a study on a comparison of student outcomes in regard to a traditional vs. a distance course in psychiatric rehabilitation.

The Employment and Disability Institute at **Cornell University** has been awarded a new grant from the U.S. Department of Education National Institute on Disability and Rehabilitation Research for a Rehabilitation Research and Training Center (RRTC) on Employer Practices Related to Employment Outcomes Among Individuals with Disabilities. This RRTC must conduct research that contributes to our knowledge about the differences that exist in employer practices towards hiring individuals with disabilities and the relationship between different practices and employment outcomes for individuals with disabilities. This new knowledge will contribute to more targeted interventions to improve employer practices related to the employment of individuals with disabilities. Cornell looks forward to working collaboratively with other NIDRR RRTC grantees, university RCE training programs, and the TACE centers nationally in this effort. **Hilbert College** is a new addition to NCRE Region II and offers an undergraduate program in Human Services and Rehabilitation Services. They report that there has been an increase in enrollment to their program this Fall. Recent graduates have found employment as



transitioning specialists at local school districts, job development and placement coordinators, addictions counselors and residential staff. There is a real appreciation of students with undergraduate education in rehabilitation and disability.

**Hofstra University** has experienced steady growth in their enrollment and programming. The program currently boasts 47 students, which is nearly a 50% increase from just 5 years ago. They have added an Advanced Certificate in Rehabilitation Counseling to assist those who would like to pursue certification under the new Category R requirements, and have finally received State approval for their Certificate of Advanced Study for Transition Specialists. This program will be accepting students in the Spring. Hofstra was just awarded one of the two RSA Long-Term Training Grants with a focus on Psychiatric Disabilities, giving the program two grants to fund student tuition. Students in the program have been an active force in the community, participating in the Long Island NAMI Walk for mental health awareness, raising over \$5000 for the cause. Faculty and students were also instrumental in hosting VOICE Day: Vision of Integration, Choice, and Equality for those with disabilities and mental health concerns. This day featured a community fair, disability awareness films, a disability history exhibit, creative arts performances by individuals with disabilities, workshops, and exhibit rooms related to transition services and advocacy. This event will become a standing community event.

In terms of distance education, Dr. Andrea Perkins has been working with a group of rehabilitation counseling educators from Auburn, Assumption College, and Utah on a collaborative teaching project for introduction to assessment. Students in this project take their traditional coursework for assessment on their campus, but are placed in teams comprised of students from four universities to complete projects in a virtual environment. Outcomes of the project will

include a wiki and webinar related to assessment topics that will be posted to the National Clearinghouse site, and students can choose to work with faculty on developing journal articles related to the topics at the conclusion of the semester. Faculty are working to develop a teaching collaboration model based on their work. Hofstra is also exploring the option of developing the CAS in Transition and possibly existing rehabilitation administration courses into online courses to accommodate continuing education needs at a distance.

**Hunter College** reports that they have moved their program from a 54 credit to a 60 credit program beginning this fall to be in line with NY state licensure standards. They are looking forward to a CORE accreditation visit in the spring.

### **Region III:**

The National Rehabilitation Association Mid-Atlantic Region has selected Dr. Kenneth Hergenrather from **The George Washington University** to receive the Region's *REHABILITATION PROFESSIONAL DEVELOPMENT AWARD*.

This award is presented to a NRA Mid-Atlantic Region member for significant contributions in the professional preparation and upgrading of rehabilitation personnel. The award signifies dedication and leadership in the pursuit of quality services to individuals with disabilities. Dr. Hergenrather was also recognized for his professional and personal dedication to his students and as a mentor to others. His extensive research and publication of professional writings extends his educational reach to an immeasurable audience.

Dr. Jim Herbert at **Penn State University** is completing his 4-year appointment as Editor of *Rehabilitation Education*. Jim wishes to thank



everyone within Region III who served as an Editorial Board member and/or contributor to the journal.

Dr. Samantha Herrick (Counselor Education doctoral student from **Penn State University**) will begin a faculty position at the **University of Medicine and Dentistry of New Jersey** in the Department of Psychiatric Rehabilitation and Counseling Professions. Congratulations, Samantha!

At **West Virginia University**, is in the second year of the CSPD RSA Scholarship grant and students from Alaska to North Carolina now consider themselves Mountaineers. This year, the general RSA Long Term training grant back into our scholarship portfolio was added..

Margaret Glenn's stint as primary coordinator of the program ended this year with the hire of a new faculty member, Dr. Dent Gitchel. Dent is a graduate of the University of Arkansas. Margaret will continue to be the Chair of the Department of Counseling, Rehabilitation Counseling and Counseling Psychology. At present, the department has a CACREP accredited program in counseling with tracks in community and school counseling, the CORE accredited program in rehabilitation counseling and an APA accredited program in Counseling Psychology. We are also in the process of hiring a new Assistant Professor of Rehabilitation Counseling.

## **Region IV:**

**Auburn University's** rehabilitation program continues today, supported by an RSA training grant (2009 – 2014), for the comprehensive system of personnel development that recruits primarily in the southeast and northwest regions. In this program, approximately twenty students per cohort begin and end their two year degree together and take the normal CORE approved RC curriculum offered to on-campus students. The students are on-campus one week per

semester, generally the first or second week of the term, and take the rest of their class on the Internet on their computer or mobile device such as the iPhone/iTouch/iPads. For most classes, the faculty teach their courses in a studio to the on-campus students while being recorded with multiple cameras and a live feed broadcast over the Internet for students who desire watching live lectures. The live feed is translated to a podcast, i.e. a program which can be downloaded by a student to their computer, later allowing them the ability to offload the lectures to their mobile devices if they desire. Students watching synchronously can interact with the class via a live chat. Students are set up with practicum and internship situations in their home area working for state VR agencies and are visited during the internship by the faculty or staff. The program has worked with sensory impaired, both blind and deaf, students and have worked out accommodations that allow those students to participate fully in classes. Over 100 students have completed this program to date with the current class graduating summer 2011 and a new class beginning fall 2011. The program is committed to developing two iPhone apps and is currently working on its first app to provide digital flash cards used in preparing for the CRC exam. AU has been offering a leadership certificate program for the past five years. This program works with advanced rehabilitation counselors providing them five leadership courses and other experiences leading to a certificate of completion. The five courses are concerned with leadership and management theory and practice in rehabilitation settings. This program uses a combination of weekend courses and Internet broadcast classes and functions within the semester timeframes.

The **University of Memphis** Rehabilitation Counseling Program is currently developing online versions of four of its core rehabilitation



counseling courses. The online version of these courses can be incorporated into the Tennessee Board of Regent's recently created graduate certificate in disability studies at The University of Memphis. The program has also developed and submitted a compressed course and distance education master's degree proposal.

**University of North Carolina at Chapel Hill** is entering the 2nd year of a RSA grant on Long-Term Training for the Mentally Ill which has an online feature for courses in the psychiatric specialization. This past year the faculty worked in partnership with its sister campus, ECU to accept one of their online lecture classes—in the hopes that these courses can also be a stand-alone certificate after the training grant is completed.

**University of South Florida**—of particular note is that after 30 years, Dr. William Emener, Distinguished Research Professor, has retired from the faculty at USF. Fortunately, the program was allowed to recruit and hire two new faculty and welcome Drs. Joan Reid and Tammy Jorgensen-Smith. In 2010, Dr. Ryan Henry received funding from the USF Center for 21<sup>st</sup> Century Teaching Excellence in the use of iPads to enhance teaching and online learning. While the program does not have a large distance education presence, it does produce a beautiful newsletter and has recently admitted 55 new on-campus students.

The **University of Tennessee** has a distance education program that is doing very well. It contains two tracks, one for general rehabilitation and the other for deafness rehabilitation. Both programs take two years to complete and each is supported with RSA grant funding.

## **Region V:**

**University of Wisconsin-Madison**  
Rehabilitation Psychology and Special Education  
School of Education

We are pleased to announce the establishment of a national research and training center to generate knowledge and evidence-based vocational rehabilitation practices that improve employment rates and quality of employment for *Rehabilitation Research and Training Center on Effective Vocational Rehabilitation Service Delivery Practices* (EBP-VR-RRTC) will be established at both the **University of Wisconsin-Madison and the University of Wisconsin-Stout** under a five year, \$5 million grant award (#H133B100034) from the National Institute on Disability and Rehabilitation Research (NIDRR), US Department of Education. Dr. Fong Chan (UW-Madison, Department of Rehabilitation and Special Education) and Dr. John Lui (UW-Stout, Stout Vocational Rehabilitation Institute) will co-direct this national research collaborative that includes Michigan State University, the University of Texas-El Paso, Southern University at Baton Rouge, Virginia Commonwealth University, and the Council of State Administrators of Vocational Rehabilitation (CSAVR) as key partners. In addition to conducting programmatic research with input from multiple stakeholders, the EBP-VR will translate new knowledge and provide training and technical assistance to public and non-profit organizations to incorporate theory-driven, culturally-sensitive, evidence-based practices into services provided to people with significant disabilities. ### **University of Wisconsin-Stout**

The 48-credit MS-VR program at U-W Stout has a well-established distance education program with a concentration in Rehabilitation Counseling. The distance education program is offered online using asynchronous instruction. It has been in operation since 2002 and is designed for individuals who work full-time. The online program has been successful in drawing nontraditional students from around the United States, as well as Canada. As of spring 2010, approximately 60 students have completed their

master's degrees through the online program. Adding the distance education component to their on-campus program has enabled UW-Stout to almost double the number of its MS-VR graduates. The faculty members at UW-Stout view the online program as playing a critical role in increasing the number of qualified rehabilitation professionals.

### **Adler School of Professional Psychology**

The Master's in Counseling: Rehabilitation (MACR) program at the Adler School is currently in its second year. As the program (and the School) continue to grow, faculty are planning to increase the number of courses offered to students in an online or blended (face-to-face plus distance) format. Currently, rehabilitation counseling students have the option of taking on-line versions of many courses that are offered across master's programs at the school and that are part of their curriculum (e.g., Life Span Development, Theories of Personality, and Career Development). Several MACR students have reported that the flexibility of the online courses is beneficial. As student enrollment in the MACR program increases, the school plan to pilot at least one of the core Rehabilitation classes to assess student interest and outcomes by the 2011-2012 academic year.

The MACR program is in the review process with CORE this year seeking candidacy for accreditation. We are happy to be establishing a strong program that is rooted in the school's mission of commitment to social justice and social responsibility.

### **Region VI:**

#### **ARKANSAS STATE UNIVERSITY (ASU)**

ASU is currently focusing on increasing enrollment in its rehabilitation graduate program as well as strengthening its emphasis on research. One example is a research project being conducted by Dr. Sharon Davis exploring factors that protect young people from drug use.



### **New Mexico Highlands University (NHMU)**

The NMHU rehabilitation graduate program is continuing to develop a specialization in vocational evaluation, with focus on models for rural settings. Dr. Doug Main reports the program is also piloting specializations in assistive technology, transition, and addictions.

### **Southern University (SU)**

Drs. Madan Kandu and Alo Dutta continue to provide RSA/NIDRR discretionary grant writing and technical assistance to faculty members of minority institutions of higher education and American Indian Vocational Rehabilitation (Section 121) programs. The Department of Rehabilitation and Disabilities Studies program provides RSA long-term training scholarship and stipend support to students, both at the graduate and undergraduate level, and offers students three areas of specialization: Assistive Technology, Rehabilitation of Ethnic Minorities, and Vocational Evaluation and Work Adjustment. The program also offers an on-line graduate program providing RSA scholarships to practicing professionals of state-federal rehabilitation agencies. Additionally, a Minority-Disability (MIND) Alliance in Science, Technology, Engineering and Mathematics (STEM) project funded by National Science Foundation, in collaboration with Hunter College of New York, has been implemented to increase the quantity and quality of students with disabilities receiving associate, baccalaureate and graduate degrees in STEM disciplines and entering the STEM workforce.

### **University of Texas – El Paso (UTEP)**

The first cohort of graduate students in this new program started in the Fall 2010 semester. Dr. Tim Tansey reports that the program is currently in the process of obtaining CORE candidate accreditation so that these students will be eligible to sit for the CRC exam. Dr. Barbara Shoen (MSU, '10) has just recently joined Dr. Tansey as a faculty member of this program. The first cohort of students, led by Ryan Rodriguez,

President of the newly formed Student Rehabilitation Counseling Association (SRCA), has already broken new ground for UTEP student associations by networking with other allied health student associations (e.g., P.T., O.T, Speech-Hearing Pathology) to hold a Rehab Sciences Social. The Social provides an opportunity for students in these various programs to come together to discuss common interests as well as develop relationships with others who will soon be working in the community providing their respective services. The SRCA has already held food drives, participated in Toys for Tots, and is planning to run as an association for the Race for the Cure event. Their next planned activity is to work together to set up a student-run health fair.

### **University of North Texas (UNT)**

Brandi Darensbourg and Chandra Donnell were elected to serve on the NAMRC Board for 2010/2011; Chandra Donnell was elected to the Texas USpra Board for 2010/2011; Tom Evenson was elected chair of the Commission on Rehabilitation Education for 2010/2011; Denise Catalano was elected to the NCRE board for 2010 – 2013; Linda Holloway was appointed the NCRE representative to the Commission on Rehabilitation Counselor Certification for 2010 – 2015; Denise Catalano was elected secretary for the North Texas Area Rehabilitation Association for 2010/2011; Martha Garber was elected to the Texas Rehabilitation Association Board and serves on the board of the North Texas Area Rehabilitation Association; and Hillary Talatzko was elected President of the UNT Staff Council for 2011.

This past fall, twenty-eight students were admitted to our on campus program, for a total of 58 students in the program. An RSA long-term training grant provides scholarship and stipend support for many of the students, and includes a stipend to attend a professional conference. We also have six graduate assistants who serve as Research Assistants and Teaching Assistants,



providing a monthly salary and benefits to these students. Our on-line graduate program, in partnership with San Diego State University, continues to see increased enrollment and provides RSA scholarship and stipend support to practicing state-federal VR counselors.

UNT JOB FIT received funding from the Department of Assistive and Rehabilitative Services (DARS) to expand services and offer paid internships and practicum's. JOB FIT was established in January 2010 with funding from the Meadows Foundation to provide employment services and peer support to individuals with psychiatric disabilities (UNT is the only university in the state of Texas to employ a full-time Certified Peer Support Specialist). This fall, under at contract with DARS, UNT was able to expand services to include all types of disabilities and provide paid internships and practicum's to select UNT rehabilitation graduate students.

UNTWISE is gearing up for our summer transition programs under the leadership of Martha Garber and Dr. Brandi Darensbourg. Dr. Yvonne Raffini, formerly with DARS, was hired as the full-time transition coordinator to lead both programs. The summer programs provide experience and pay for approximately 40 undergraduate and graduate students. These programs include:

**The Real Employment and Learning (REAL) program (in partnership with the Texas Division of Blind Services)** has expanded to serve 20 transition students who are blind or visually impaired. The students live in dorms on campus and learn independent living skills such as shopping, cooking & budgeting while being employed in jobs throughout the Denton community. The program also provides summer employment for UNT graduate and undergraduate students as job coaches, independent living skills trainers, and residential counselors.

**The Career Crusin' Camp (C3)**, a week long program focused on assisting transition age students to develop career goals, is beginning its third year of operation. The program has a heavy emphasis on career exploration, including job shadowing and information interviews, as well as information on disclosure and negotiating accommodations. The camp includes a wellness component with students from UNT's Kinesiology and Therapeutic Recreation program leading campers in physical activities and recreation.

UNTWISE is also developing several training programs for service providers. In cooperation with DARS, a web-based program is being developed to train and certify all Community Rehabilitation Program (CRP) providers who deliver supported employment services to DARS consumers. Over 1,300, job Coaches, Job Skills Trainers, Job Placement Specialists, Supported Employment Specialists and CRP Directors who work with DARS consumers will be required to complete this mandatory training. In cooperation with the Texas Division of Blind Services (DBS), two web-based training programs in Self-employment are in development. The first course is designed for DBS counselors who assist consumers interested in self-employment. The course covers policy considerations as well as planning and assessment tools to support the development of an IPE and a business plan. The second course, in collaboration with the Hadley School for the Blind, will be designed for consumers.

## **Region VIII:**

### **The University of Northern Colorado**

continues to experience growth in both of the graduate programs (Ph.D. in Human Rehabilitative Services and M.A. in Rehabilitation Counseling) and the undergraduate program in Human Services. Dr. Juliet Fried received a sabbatical leave for the fall semester and is working with faculty at the University of Wisconsin – Stout to develop new training and research opportunities. The Master's Program in Rehabilitation Counseling also recently received long-term training funding. Currently, faculty at the University of Northern Colorado provide a hybrid distance-education program. Approximately one half of the core rehabilitation counseling courses are offered completely online. Students continue to complete internships in various programs across the nation, and when needed supervision is provided using distance-education technology

**The University of North Dakota** has set new enrollment records this fall, both at the University level and within our graduate and undergraduate rehabilitation programs. The university now has over 14,000 students, while our master's programs (rehab, addiction, mental health, and school counseling) have over 75 students. Our undergraduate program is also growing with a current enrollment of 32. In addition, our APA-accredited PhD program in Counseling Psychology has an enrollment of 24 students, several of which are emphasizing rehabilitation and addictions.

Our two full-time rehabilitation and addictions faculty continue to be very busy. Dr. Tony White serves on the IARP Board and is very active with his research agenda. Dr. David Perry returned to full time responsibilities this summer, after doing a sabbatical at the Adler School of Professional Psychology in Chicago during the last academic year. He was appointed to the CORE Board earlier this year, by virtue of his

position as chair of CORE's Undergraduate Commission.

Distance education options are rapidly increasing at UND. At the present time the only distance education program offered by our department is in school counseling, but we are considering expanding that to our other programs.

Dr. Jared Schultz is now the Rehabilitation Counseling Program Director at **Utah State University**. The faculty expresses deep appreciation to Dr. Julie Smart for the wonderful job and strong leadership she has provided in this capacity for over 10 years. Utah State has also started a rehabilitation counseling clinic on campus to provide services to persons with disabilities in the community. This clinic provides a unique opportunity for training and clinical research. It is the result of strong partnerships with the special education faculty in our department and the Utah State Office of Rehabilitation.

Utah State University has a distance-based master's degree program. Our distance students participate in classes synchronously with our on-campus students via the internet. Practicum and internship supervision are conducted using videoconferencing technology integrated with DVD equipment, which allows us to conduct peer supervision and evaluate recorded counseling sessions in real time. All students are required to have a webcam and headset to engage in distance-based clinical supervision. We currently have CSPD and long-term training funding for our programs and are in the process of approving a certificate program through the university for the new Category R approved by CRCC.

**Montana State University**, College of Allied Health Professions, Department of Rehabilitation and Human Services offers a 60 semester hour Master of Science in Rehabilitation and Mental Health Counseling. The program is CORE



accredited and meets the academic course content requirements for state licensure. Courses are offered on a rotational basis and can be completed online or in the evenings. Distance education students can complete the entire program online.

The **Region 8 TACE Center** continually conducts several distance learning opportunities. Programs including new counselor trainings, motivational interviewing, rural job development, ex-offender employment opportunities, and ethics are all offered using distance education. Specific certificate programs including ‘National Certificate in Employment Services: Get Work Now!’ and an eight week brain injury certification are offered online through the Region 8 TACE Center.

The Region 8 TACE has also been highly involved in the Community of Practice related to Program Evaluation and Quality Assurance in State VR. They just completed their 3<sup>rd</sup> Annual Conference in September. A number of rehabilitation education institutions begun to become involved. The Summit Group has numerous resources which can be accessed at [www.ncrtm.org](http://www.ncrtm.org) (National Clearinghouse of Rehabilitation Training Materials) and is planning many activities for the next year. We are beginning to look at the competencies which are necessary for State VR Program Evaluation and Quality Assurance Specialists to succeed in their jobs.

## **Region IX: California State University, Fresno**

The Center for Disability Innovation at the Rehabilitation Counseling Program at Fresno State was awarded a five-year \$2.5 million grant to establish a residential program for transitional youth with intellectual disabilities in October. The residential program is called Wayfinders.

Wayfinders expect to take in the first 12

residents this fall. This is the only residential program for these youth in California to provide vocational training and placement.

The Employment Network (EN) is one of the clinics in the Rehabilitation Counseling Program at California State University (EN). The EN Model is based on the Ticket to Work program and has been integrated into the classroom so that students get a valuable “hands on” learning experience in Social Security Administration, SSI, SSDI, and Work Incentives.

On average, 6-8 graduate students per semester work with 2-3 Ticket Holders. Students have an opportunity to advance their knowledge about disability, continue to practice interpersonal communication skills and establish vocational rehabilitation goals in the areas of job development, job placement, and job retention.

The development of partnerships with organizations within the community such as the California Department of Rehabilitation and the local Center for Independent Living (Resources for Independence-Central Valley, RICV) have helped establish the success of the EN.

## **San Diego State University**

The San Diego State University Rehabilitation (SDSU) Counseling Program (RCP) instituted a new certificate program to provide applicants with the requisite coursework needed to apply for



the CRC under the new Category R option. The Certificate Program is available to prospective students both on-campus and on-line.

Four SDSU RCP students took part in international internships during the Fall 2010 semesters. Two students were placed in an orphanage in Oaxaca Mexico, and two others completed internships at a university in Dublin followed by placement to a brain injury support agency in Galway Ireland. The RCP will continue to explore other international training opportunities for our students as well as to

encourage enrollment of students from across the world.

The SDSU RCP student group, the Rehabilitation Counseling Association, has been very active in helping guide the direction and spirit of the program. RCA recently instituted a mentoring program, where more advanced students are paired with incoming students to guide their development throughout their studies. Further, RCA holds training/tutoring programs to help prepare students for the CRC exam and the RCP's comprehensive examination.
