**Terms and Conditions
Members Site (MyNCRE Login)**

Introduction

These Terms and Conditions govern your use of the National Council on Rehabilitation Education (NCRE), Members Site (MyNCRE login) hosted at www.ncre.org. By using this website, you accept these Terms and Conditions in full. If you disagree with these Terms and Conditions or any part of these Terms and Conditions, you must not use the Members Site (MyNCRE login).

Eligibility

The NCRE Members Site (MyNCRE Login) is intended for the person who has paid their membership dues for the **September 1, 2015 – July 1, 2016** year.

- Student Member (Undergraduate, Graduate, and Doctoral)
- Emeritus Member
- New Career Member
- Individual Member
- Institutional Membership (designated contact person and/or program coordinator)

Membership Accounts will deactivate on July 2, 2016. Members will have to renew membership on July 1, 2016 for the next membership year of July 1, 2016 – July 1, 2017 to continue accessing the Members Site (MyNCRE Login).

Registered Membership Account

In order to access the MyNCRE Login membership features you must create an account. You represent and warrant that the information provided to NCRE upon completing the membership application, is true, accurate, current and complete. Username and Password
